#### Volunteer Release and Waiver of Liability Policy

Article I: Purpose

To educate each volunteer that the Foundation will assume no liability regarding risks that may be associated with volunteer activities associated with the Sunland Village East Foundation. Once signed, the signed Volunteer Release and Waiver of Liability Form shifts the responsibility for injuries, damage, or loss from the Foundation to the volunteer.

Although it is anticipated that there will be few risks associated with volunteering for this nonprofit, charitable corporation, some will exist due to human activity. Rarely, volunteers may offer to use their personal vehicle, equipment, tools, or other items on behalf of the Foundation.

All volunteers shall be encouraged to carry personal liability and injury insurance coverage.

#### Article II: Procedure

At the volunteer's initial presentation, and at least annually thereafter, each volunteer shall review and sign the SVE Foundation Release and Waiver of Liability Form.

The Secretary of the Board of Trustees shall maintain all signed Release and Waiver of Liability forms.
